## **INFANT/TODDLER AND YOUNG 2'S**

**First Day of registration is Monday 3/15/21**

**First day of school is Monday 8/16/21**

**Last day of school is Thursday 6/9/22**

PELC is happy to invite you to register for our on-campus classes for the 2021-2022 school year!

For current, returning, and new families:

- All families should complete and email this form to PELC (pelc@svpc.us) beginning 3/15/21.
- Registration forms from current and returning families will have priority until 3/21/21.

The following fees will be collected once enrollment in your class has been confirmed.

- Registration fee of \$150.
- Tuition deposit of half a month for your class, to be used for August tuition.
- If you choose to cancel your enrollment, the tuition deposit is fully refundable until 5/31/21.
- Registration and tuition deposit fees are fully refundable if PELC is unable to provide your child's class.

### **Class Placement**

- We will confirm your class enrollment by personal contact beginning 3/29/21.
- Once class placement is confirmed your registration fee and tuition deposit will be collected.

### **PELC Tuition Policy:**

- All payments will be made via Tuition Express, using an automated ACH bank transfer from your bank account to PELC's bank account. You must be willing to sign up for Tuition Express through PELC, which includes disclosing your bank account number.
- Monthly tuition will be collected via Tuition Express on the 5<sup>th</sup> of each month.
- Part-time tuition is based on a yearly rate. August is a half month's tuition and is paid at the time of enrollment confirmation. You will pay the regular monthly tuition for September through May. The tuition remains the same for each of these months regardless of the number of school days in the month. June is a partial month and tuition is based on the number of days your class meets. PELC will charge the daily rate for June.

### **Infant/Toddler Program (Child must be at least 5 months old)**

Teacher to child ratio is 1:4. Class size is 8 students. You may sign up for 1 or 2 days.

Monday 9am-2pm    \$360/month

Wednesday 9am-2pm    \$360/month

### **Young 2's Program (Child turns 2 just before school begins or during the school year)**

Teacher to child ratio is 1:6. Class size is 12 students. You may sign up for 1 or 2 days.

Tuesday 9am-2pm    \$360/month

Thursday 9am-2pm    \$360/month

### **I understand that:**

1. The following fees will be collected once my child's enrollment has been confirmed: registration fee of \$150 and half a month's tuition to be used for August 2021 tuition. Money is fully refundable if PELC is unable to provide my child's class. If I change my mind, the tuition deposit is fully refundable up until 5/31/21.
2. Monthly tuition will be paid via Tuition Express as an ACH bank transfer and I agree to sign up for Tuition Express through PELC which includes disclosing my bank account number.
3. No credits or refunds can be given because of illness or vacation.
4. Thirty (30) days notice in writing is required to withdraw from the program once it begins.
